Moved by Rippen; seconded by Scott to increase the Jr/Sr High student lunch price to \$3.25, and to leave the elementary lunch price at \$2.75 for the 2019-2020 school year. Aye votes Scott, O'Byrne, Rippen, Hagan, Kolbet, and Marks; nay votes none.

Superintendent Sattler reviewed all additions, clean-ups, and any changes in the Student-Parent, Certificated, and Classified Handbooks for the 2019-2020 school year. Moved by Kolbet; seconded by Marks to approve the Student-Parent, Certificated, and Classified Handbooks for the 2019-2020 school year as presented. Aye votes O'Byrne, Rippen, Hagan, Kolbet, Marks, and Scott; nay votes none.

Superintendent Sattler would like to begin to developing a three year strategic plan for the Hitchcock County School District. Board members agreed to meet at the elementary site on June 10, 2019 at 5:30 PM. They will walk through the site and discuss what they would like to achieve. They will then move to the Jr/Sr High site. They will walk through the site and discuss what they would like to achieve. The board will then meet in the distance learning room where they will open the June 10, 2019 regular board meeting at 7:30 PM.
