The Board of Education of the Hitchcock County Schools met September 10, 2018 at 7:00 PM at the Hitchcock County Jr/Sr High School. Present were board members Scott, O'Byrne, Rippen, Hutto, and Kolbet. Marks was absent. Also present were Superintendent Sattler, Principal Tines, R. Rath, S. Porter, A. Wright, J. Rahrs, and Peggy Fyn.

President Scott called the meeting to order at 7:00 PM. Notice of the board's adherence to the Nebraska Open Meetings Law posted on the north wall of the meeting room was given.

Moved by Kolbet; seconded by O'Byrne to excuse Marks. Aye votes O'Byrne, Rippen, Hutton, Kolbet, and Scott; nay votes none.

Moved by Hutto; seconded by Kolbet to approve the September 2018, Regular Meeting Agenda as presented. Aye votes Rippen, Hutto, Kolbet, Scott, and O'Byrne; nay votes none.

President Scott welcomed all visitors. New teachers Rath, Porter, and Wright introduced themselves to the board members.

Moved by Kolbet; seconded by O'Byrne to approve the consent agenda as presented. Aye votes Hutto, Kolbet, Scott, O'Byrne, and Rippen; nay votes none. The consent agenda consisted of the following items: (1) Minutes of the August 2018 regular board meeting. (2) The Activity Fund. (3) The bill rosters with general fund bills totaling \$403,510.26 and lunch fund bills totaling \$22,195.03. (4) Other funds.

Superintendent Sattler reviewed with board members the Alicap insurance findings.

Moved by Rippen; seconded by Hutto to recognize the Hitchcock County Educators Association as the official bargaining unit for the 2020-2021 school year. Aye votes Kolbet, Scott, O'Byrne, Rippen, and Hutto; nay votes none.

Superintendent Sattler presented the board with quotes from Bosselman Energy and Farmers Coop for propane bids for the coming season. Bosselman Energy bid \$1.29 per gallon on a pay as you go billing. Famers Coop bid \$1.37 for prepay. Moved by Kolbet; seconded by Scott to approve Bosselman Energy at \$1.29 per gallon pay as you go for the Jr/Sr High buildings and to prepay \$40,000 to Farmers Coop for the elementary building. Aye votes Rippen, Hutto, Kolbet, Scott, and O'Byrne; nay votes none.

Superintendent Sattler presented the board with two proposals for millings for the west side of the elementary building. T&K Ventures for \$10,225.00 and Liberty Custom Services for \$9,470.00. After much discussion about descriptions of services and tons of millings it was moved by moved by Rippen; seconded by Kolbet to accept the proposal from T&K Ventures for \$10,225.00 to put millings on the west side of the elementary building. Aye votes Scott, O'Byrne, Rippen, Hutto, and Kolbet; nay votes none.

Hitchcock County Elementary has been nominated for the Blue Ribbon Award. Final notification will be given after assessment scores have been reviewed. As Mr. Kershaw was principal when the notification of nomination was given, Mr. Sattler asked the board to pay for travel expenses to Washington D.C. to accept the award if it is awarded to the elementary. Moved by Rippen; seconded by O'Byrne to pay for Mr. Kershaw's travel expenses to Washington D.C. to accept the Blue Ribbon Award for Hitchcock County Elementary. Aye votes O'Byrne, Rippen, Hutto, Kolbet, and Scott; nay votes none.

Moved by Rippen; seconded by Scott to adopt the property tax request resolution for Hitchcock County Schools, District #44-0070 with the General Fund levy of 0.835140, the Bond Fund levy of 0.111749, and the Special Building Fund levy of 0.017875. WHEREAS, public notice was given at least five days in advance of a Special Public Hearing called for the purpose of discussing and approving or modifying the District's Tax Requests, for the 2017-2018 school fiscal year for the General Fund and Special Building Fund of Hitchcock County School District 44-0070. WHEREAS, such Special Public Hearing was held before the Board of Education (hereinafter "the Board") of Hitchcock County School District 44-0070 (hereinafter "the District") at the time, date, and place announced in the notice published in a newspaper of general circulation, a copy of which notice and proof of publication is attached hereto as Exhibit A, all as required by law; and, WHEREAS, the Board, provided an opportunity to receive comment, information and evidence from persons in attendance at such Special Hearing; and, WHEREAS, the Board, after having reviewed the District's Tax Request for said fund, and after public consideration of the matter, has determined that the Final Tax Requests as listed below are necessary in order to carry out the functions of the District, as determined by the Board for the 2018-2019 school fiscal year. NOW BE IT THEREFORE RESOLVED that the Tax Request for the General Fund should be, and hereby is set at \$3,539,463.60 for the 2018-2019 school fiscal year, and the Bond Fund K-12 should be, and hereby is set at \$473,610.10 for the 2018-2019 school fiscal year, and the Building Fund should be, and hereby is set at \$75,757.58 for the 2018-2019 school fiscal year. (3) The elementary hosted half of the HS volleyball teams involved in the Hitchcock County Schools volleyball tournament. (4) Today, September 10th, was the last day of MAAPS testing for the elementary. (5) If the elementary receives the Blue Ribbon Award, there will be a celebration October 25th or November 20th. (6) There is no school on September 19th. Teachers will attend a PLC workshop that day.

Superintendent Sattler gave an AD report. (1) The football team is currently 2-1, tied for 1st in the district with a bye this week. (2) The volleyball team has a 7-2 record. They took 2nd place in the Hitchcock County Tournament on Saturday. (3) Cross country has had a few placings in their meets. Two JH runners competed last week. (4) The JH football and volleyball teams both have a win. (5) Play production has begun practices. (6) Next year's 2019-20 contests and officials are nearly scheduled.

Superintendent Sattler's report as follows: (1) The new activity bus will be getting new decals. (2) One of the 28 passenger buses has arrived and has been paid for. Mr. Sattler is waiting for a quote on another 28 passenger bus. (3) Mr. Sattler will be unable to attend the NASB membership meeting in North Platte on September 26th. He encouraged

board members to attend. (4) Mr. Sattler will be attending the School Law Update in Kearney on September 26^{th} . (5) The NASB State Conference is November $14^{th} - 16^{th}$. (6) Teachers will be attending PLC workshops on September 19^{th} .
