Moved by Jarecke; seconded by Baker to move into executive session at 7:18 PM to discuss teachers' negotiations. Aye votes Marks, Ferguson, Matson, Jarecke, Baker, and Kolbet; nay votes none.

Moved by Jarecke; seconded by Matson to move out of executive session at 7:34 PM.
