President Scott welcomed all visitors.

Moved by Rippen; seconded by Hutto to approve board mileage check 26929, Larry Marks, for \$224.70. Aye votes Scott, O'Byrne, Rippen, Hutto, and Kolbet; Marks abstained.

Moved by Kolbet; seconded by Marks to approve board mileage check 26930, Casha O'Byrne, for \$89.88. Aye votes Marks, Scott, Rippen, Hutto, and Kolbet; O'Byrne abstained.

Moved by Marks; seconded by O'Byrne to approve board mileage check 26931, Theodore Rippen, for \$82.39. Aye votes O'Byrne, Hutto, Kolbet, Marks, and Scott; Rippen abstained.

Moved by Rippen; seconded by O'Byrne to approve 2018 board member committee assignments as presented. Aye votes Hutto, Kolbet, Marks, Scott, O'Byrne, and Rippen; nay votes none.

Superintendent Sattler introduced Andy Long from Mid-Plains Community College to the board members. Mr. Long gave a power point presentation to the board on the mission, campuses, distance learning sites, legislated goals, and funding of Mid-Plains Community College. Mr. Long addressed questions from board members.

Superintendent Sattler introduced Jay Wickman from W-Design Associates. Mr. Wickman presented the board with the architect's proposal for a multi-purpose area and weight room addition. Mr. Wickman addressed questions from board members on square foot specifications, cost breakdown, scheduling time frame, etc. The board asked Superintendent Sattler to make the multi-purpose area and weight room addition an action item on the regular February 2018 board agenda.

(2) Clear Touch boards were installed in elementary classroom over the break. Training took place on January 2<sup>nd</sup>. (3) The girls' basketball team won the Brady Holiday tournament. The boys' basketball team placed 3<sup>rd</sup>. (4) The wrestling team placed 2<sup>nd</sup> at the Dundy County Invite. (5) RPAC Quiz Bowl is January 10<sup>th</sup> at 1:00 PM in Maywood. (6) RPAC Art Contest is January 17<sup>th</sup> at 1:30 PM in Cambridge. (7) RPAC Wrestling is January 19<sup>th</sup> at 2:30 PM in Southern Valley. (8) RPAC basketball, 1<sup>st</sup> round is January 20<sup>th</sup> at 11:00 AM in Trenton.

Superintendent Sattler's report as follows: (1) The staff is extremely grateful for the gift cards. (2) The new lights in the gym at the elementary have been installed. (3) The blue ribbon award nomination for the elementary is an honor. (4) A handout from the NCSA of legislative bills. (5) HCS has become an ACA large employee. We will research options available in order to meet the employer shared responsibility mandate and bring those options back to the board for discussion and action. The board will need to make a decision prior to the August 2018 board meeting. (6) The heaters on the gym roof at the elementary are fixed.
