The Board of Education of the Hitchcock County Schools met May 14, 2018 at 7:00 PM at the Hitchcock County Jr/Sr High School. Present were board members Scott, Marks, Kolbet, and O'Byrne. Absent Rippen and Hutto. Also present were Superintendent Sattler, D. Wimer, N. Thiessen, W. Merrill, a student, and Peggy Fyn.

President Scott called the meeting to order at 7:00 PM. Notice of the board's adherence to the Nebraska Open Meetings Law posted on the north wall of the meeting room was given.

Moved by Marks; seconded by Kolbet to excuse board members Hutto and Rippen. Aye votes Scott, O'Byrne, Kolbet, and Marks; nay votes none.

Moved by Kolbet; seconded by O'Byrne to approve the May 2018 regular meeting agenda as presented. Aye votes O'Byrne, Kolbet, Marks, and Scott; nay votes none.

President Scott welcomed all visitors.

Moved by Marks; seconded by Kolbet to approve the consent agenda as presented. The consent agenda consisted of the following items. (1) Minutes of the April 2018 regular board meeting. (2) Minutes of the April 9, 2018 and April 23, 2018 special board meetings. (3) The Activity Fund. (4) The bill rosters with general fund bills totaling \$313,016.42 and lunch fund bills totaling \$17,498.01. (5) Other funds.

Moved by Scott; seconded by Kolbet to increase 2018-2019 hot lunch prices to \$2.75, PreK, through 6th grade; \$2.95, 7th grade through 12th grade; and extra milk to \$.35. Aye votes Marks, Scott, O'Byrne, and Kolbet; nay votes none.

Superintendent Sattler presented the board with a proposal for the construction of the greenhouse for \$10,500.00. The board would like to possibly see more bids. They instructed Mr. Sattler to send letters to area contractors to see if there is any more interest in the construction project. The board would like to receive \$8,727 of the donation money that has not been given to the school as of the board meeting before a decision is made for construction. This item was tabled.

Superintendent Sattler presented the board with a proposal from Coach Masters for two used 2017 Chevrolet Thomas Mino Tour 29 passenger buses for \$49,650.00 each. Moved by Marks; seconded by Kolbet to purchase two 2017 Chevrolet Thomas Mino Tour 29 buses from Coach Masters for \$49,650.00 each with possible trade-ins to be paid for from the depreciation fund. Aye votes Marks, Scott, O'Byrne, and Hutto; nay votes none.

Superintendent Sattler presented the board with proposals for purchase of a new mower. Bernie Jones Automotive – 2018 Grasshopper Model 900D plus trade-in for \$11,000. Lang Diesel Inc – 2016 Grasshopper 725DT6 plus trade-in for \$10,800.00. Moved by Scott; seconded by Kolbet to accept the proposal from Bernie Jones Automotive for \$11,000.00 to be paid out of the depreciation fund. Aye votes Scott, O'Byrne, Hutto, and Kolbet; nay votes none.

Superintendent Sattler presented the board with a proposal from Lakeside Sand and Gravel for \$16,500 to put crushed asphalt on the lot east of the school for student parking. After discussion the board asked Mr. Sattler to follow up with a new proposal for the lot north of the school for student parking. No action was taken on this item.

High School Cross Country coach Natalie Thiessen spoke with the board about adding junior high cross country. One junior high student also spoke with the board. Practice would be after school with the high school cross country team, three days a week. The junior high athletes would attend 2-4 meets. There are ten junior high students that expressed an interest in cross country. There will be minimal to no cost. President Scott instructed Mrs. Thiessen to work out any details with Superintendent Sattler.

Moved by Kolbet; seconded by O'Byrne to offer the elementary principal contract to Michael Tines for the 2018-2019 school year. Aye votes Kolbet, Marks, Scott, and O'Byrne; nay votes none.

Moved by Kolbet; seconded by Marks to approve a contract with Scott Porter as the elementary physical education teacher for the 2018-2019 school year. Aye votes Kolbet, Marks, Scott, and O'Byrne; nay votes none. Mr. Porter will also be an assistant high school football coach, and head junior high football, wrestling, and track coach.

There was no committee report.

There was no principal/athletic director report

Superintendent Sattler's report as follows: (1) There were three qualifiers for State Track. Kass Kisker in the triple jump and 100 meter hurdles; Kyleigh Scott in the pole vault, the 100 meter dash, and the 200 meter dash; and Jasmine Youngquist in the high jump. (2) Remington Hodges and Darian Hutto qualified for State Golf. (3) Mr. Sattler met with Todd Boldt from Miller and Associates for a structural quote for the possible wrestling room at the elementary.

President Scott adjourned the meeting at 8:10 PM. The next board meeting will be held June 11, 2018 at 7:00 PM, at the Hitchcock County Jr/Sr High School. The agenda kept continuously current is available to the public for items of an emergency nature. The meeting is open to the public.
