Moved by Rippen; seconded by Baker to approve the consent agenda as amended. Aye votes Marks, Scott, Rippen, Baker, and Kolbet; nay votes none. Moved by Baker; seconded by Rippen to approve check 24945 (Aaron Kolbet). Aye votes Rippen, Baker, Marks, and Scott; nay votes none. Kolbet abstained.

Moved by Baker; seconded by Scott to approve check 25945 (Larry Marks). Aye votes Baker, Kolbet, Scott, and Rippen; nay votes none. Marks abstained.

Moved by Marks; seconded by Baker to approve check 25964 (Theodore Rippen). Aye votes Kolbet, Marks, Scott, and Baker; nay votes none. Rippen abstained.

Casha O'Byrne was welcomed as a new board member and was administered the oath of office.

Moved by Rippen; seconded by Baker to retain the 2016 board officers in their current positions for the 2017 year. Aye votes Baker, Kolbet. Rippen, Marks, Scott, and O'Byrne; nay votes none. Board officers as follows:

Board members reviewed a list of committees and members assigned to each. President Scott asked that a budget committee be added to the list. Deb McCarter presented the board with information about the secondary PBiS program, the Response to Intervention (RTI) program, and the AQuESTT Accreditation System. Ms. McCarter reviewed a handout on the six tenets of AQuESTT, the State of Nebraska's program for evaluating schools. Board members had a chance to have all questions answered.

An ad will be placed for the sale of the bleacher boards to be removed from the site within the days mentioned above. Any boards left over will be given to the Hitchcock County Schools Foundation to be used as a fund raiser. Moved by Kolbet; seconded by O'Byrne to advertise the bleacher boards for sale. Aye votes O'Byrne, Rippen, Baker, Kolbet, Marks, and Scott; nay votes none.

Moved by Rippen; seconded by Kolbet to move into executive session at 7:56 PM to discuss an administrative contract for John Kershaw. Aye votes Kolbet, Rippen, Marks, Scott, O'Byrne, and Baker; nay votes none.

Moved by Marks; seconded by Baker to move out of executive session at 8:12 PM. Aye votes Rippen, Marks, Scott, O'Byrne, Baker, and Kolbet; nay votes none.

Move by Scott; seconded by Kolbet to offer John Kershaw a one year extension to the contract for the 2017-2018 school year, with a 2% salary increase. Aye votes Rippen, Baker, Kolbet, Marks, Scott, and O'Byrne; nay votes none.

Committee report as follows: (1) O'Byrne attended the NASB's new board member workshop.

Principal/AD Kershaw's report as follows: (1) S. Johnson was hired for the PreK Para position. (2) The 3<sup>rd</sup> – 6<sup>th</sup> grade teachers had an in-service January 6<sup>th</sup> in the AM to prepare for the ESU In-service in McCook on January 16<sup>th</sup>. (3) Mrs. Smith and the student PBiS kids raised \$75.25 for the McCook Humane Society. (4) The elementary paired up with the Culbertson library to sponsor a book fair. Each teacher will receive \$76.84 to spend on books for the classrooms. (5) The boys basketball team won the Brady Holiday tournament. (6) RPAC Quiz Bowl on January 11<sup>th</sup> at Southwest High School. (7) RPAC Art contest on January 18<sup>th</sup> at Cambridge. (8) RPAC wrestling January 20<sup>th</sup> at Med Valley High School. (9) First round of RPAC basketball will be January 21<sup>st</sup> at Dundy County High School.
