Mr. Sattler informed the board the technology committee had met, and what their recommendations were. All to be paid for from the Depreciation Fund with purchase costs supplemented with a \$20,000 grant from the Hansen Foundation and \$16,993.57 in REAP monies. David Wimer presented the board with proposals for an activity bus from Thomas- Omaha, Cornhusker International, and NE Central Equipment. Moved by Baker; seconded by Kolbet to accept the proposal from Cornhusker International not to exceed \$141,275.00 to be paid from the Depreciation Fund. Aye votes Kolbet, Marks, Scott, O'Byrne, Rippen, and Baker; nay votes none.

Moved by Baker; seconded by Kolbet to revise Board Policy 3012, School Meal Program and Meal Charges, and to adopt Board Policy 5050, School Wellness, as presented, Aye votes Marks, Scott, O'Byrne, Rippen, Baker, and Kolbet; nay votes none.

Moved by Rippen; seconded by O'Byrne to add spring parent-teacher conferences on February 8, 2018 from 1:00 PM to 8:00 PM, with a noon dismissal, to the 2017-2018 school calendar as proposed. Aye votes Scott, O'Byrne, Rippen, Baker, Kolbet, and Marks; nay votes none.

Moved by Baker; seconded by Marks to amend Cathy Barger's contract for the 2017-2018 school year as presented. Aye votes O'Byrne, Rippen, Baker, Kolbet, Marks, and Scott; nay votes none.

Moved by Kolbet; seconded by Baker to approve a contract with Nathaniel Acton for the K-12 Instrumental/Vocal instructor for the 2017-2018 school year. Aye votes Rippen, Baker, Kolbet, Marks, Scott, and O'Byrne; nay votes none.

Moved by Kolbet; seconded by Marks to accept Dove Lacey's resignation at the end of the 2016-2017 school year. Aye votes Baker, Kolbet, Marks, Scott, O'Byrne, and Rippen; nay votes none.

Moved by Baker; seconded by Kolbet to move into executive session at 8:12 PM to discuss 2017-2018 classified wages. Aye votes Baker, Kolbet, Rippen, Marks, Scott, and O'Byrne; nay votes none.

Moved by Marks; seconded by Kolbet to move out of executive session at 8:50 PM. Aye votes Marks, Scott, O'Byrne, Baker, Kolbet, and Rippen; nay votes none.

Moved by Rippen; seconded by Baker to adjust the 2017-2018 classified wages up to 3% for all positions except for the nurse and custodial 1. Aye votes Kolbet, Marks, Scott, O'Byrne, Rippen, and Baker; nay votes none.

Moved by Kolbet; seconded by Marks to increase the school nurse pay to \$25 per hour and to rename custodial 1 to Grounds, Maintenance, and Transportation Director with an increase to \$18.43 per hour for the 2017-2018 school year. Aye votes Kolbet, Scott, Rippen, O'Byrne, Baker, and Marks; nay votes none.

Committee report as follows: Board member Rippen gave a report on keynote speakers, breakout sessions, and new legislation that were a part of the NRSCA conference he attended in Kearney.
