Moved by Kolbet; seconded by Rippen to move into executive session at 7:25 PM to review KSB School Law's advice regarding the RW8 tax collection issue. Aye votes Kolbet, Marks, Scott, O'Byrne, Rippen, and Hagan; nay votes none.

Moved by Hagan; seconded by Kolbet to move out of executive session at 4:41 PM. Aye votes Marks, Scott, O'Byrne, Rippen, Hagan, and Kolbet; nay votes none. No action was taken.
